A. Please describe your sustainability initiative and attach supporting documentation.

On a university campus the size of Virginia Tech, with almost all students using electronic appliances, there is an abundance of broken or unused appliances. Old phones, computers, televisions, and household or kitchen appliances lay around for months because there is no convenient and easy way to dispose of these electronics. Our sustainability initiative is to set up two pilot e-waste recycling bins on campus, in Goodwin Hall and on the first floor of the library. The e-waste in these bins would be collected monthly by Virginia Tech's Environmental Health and Safety department. It is very important to the success of these recycling bins that the student body is well-informed about their purpose and location. A crucial part of our initiative would be to promote these e-waste recycling bins through a campus wide campaign of posters and flyers. Information such as what appliances are safe to recycle and where the bins can be found will be on the flyers. We hope that by making recycling of e-waste more convenient it will lead to more students recycling their electronics in a safe, sustainable, and environmentally conscious manner.

B. How does this initiative help to achieve the goals of the Virginia Tech Climate Action Commitment Resolution and Sustainability Plan?

Our proposal aims to achieve goals 1, 5a and 8 of the Climate Action Commitment Resolution and Sustainability Plan. It will achieve goal 1 by promoting sustainable practices on campus through the proper disposal of e-waste. This will divert an abundance of waste away from landfills on campus and direct to the proper disposal sources. Our proposal will address goal 5a of the Sustainability Plan because it coordinates a program on campus with the students and EHS in order to promote sustainability on campus. Finally, our proposal will achieve goal 8 of the Sustainability Plan by greatly reducing the amount of waste the ends in up in landfills by diverting a greater amount of e-waste on campus to be recycled.


